1 Introduction

This document presents the CML tool for Toolkit 2 on Community Policing:

This toolkit will engage key decision-makers in community policing in Lisbon, thereby ensuring it is valued and that community police officers are not diverted onto other police tasks.



3 Concept background (the problem)

- Problem that the toolkit addresses: The diversion of community policing officers to other police
 activities (e.g. securing the area around the Lisbon City Council/ patrolling other areas than the
 neighbourhood assigned for the community policing). There is a need to change the mindset of
 senior police officers (decision makers) to value and support the community policing model in
 Lisbon.
- Lack of senior level support and engagement: The toolkit is needed to promote senior officers' involvement and ownership of the community policing model in Lisbon.
- Senior police officers need to understand better the community policing model, how it allows a
 better understanding of the "other" and about the community policing officers role in the
 community, in order to value it. Due to the lack of human resources, the community policing
 officers are allocated frequently to other police activities since they are not perceived by senior
 officers and by their peers as 'real' police officers with an important role in community security.
- Conflicting roles between traditional police officers (the 'real' police a 'hard' approach) and community policing officers (a 'soft' approach): "The community policing officer role to the eyes of police peers, their identity as police officers are more related to law enforcement, authority than a supporting role to social needs of citizens" (Interview#1 6.12.2019). The community policing officers need to balance these conflicting roles of supporting citizen's social needs with law enforcement.



4 Concept description (the solution)

The toolkit consists of an information and engagement strategy, supported by associated materials and several events, to promote the concept and value of community policing to CML/Lisbon Municipal Police senior police officers and other related decision-makers (including the mayor, deputy mayor and commanders). Communication materials will be both physical (i.e. brochure; 'Overview' document) and use other media (i.e. videos; website; e-newsletter).

The toolkit will seek to change the mindset of senior officers / decision-makers towards community policing and motivate them to support and engage with the programme over the longer term.

The toolkit will include a 'handbook' for community policing that provides more in-depth information about how community policing is delivered. (However, this may not be appropriate for some senior officers/decision-makers who are unlikely to read such material). It will also be implemented several key events to engage senior officers in the planning process of the community policing in the city of Lisbon (e.g. Planning Labs; Annual Community Policing Celebration Event).



5 Focus of the toolkit concept

- Senior officers/decision-makers improved understanding of/and engagement in, community
 policing, will reduce negative interference (i.e. re-assigning of community policing officers onto
 different policing tasks)
- Active participation of senior officers in the planning and strategic delivery of community
 policing will result in increased sense of 'ownership' and so longer-term engagement and
 support.



6 Who is the toolkit for?

Targets / users of the toolkit

- Senior police officers (most important for ensuring community policing officers remain dedicated to role)
- Other decision-makers (i.e. Mayor and Deputy Mayor for Security)
- Other stakeholders (i.e. Presidents of 24 Parish Councils)1.

Beneficiaries of the toolkit

- Community Policing Brigade/Lisbon Municipal Police-CML (community police officers that operationalize the community policing projects in the several Lisbon neighbourhoods)
- Prevention and Security Team/Lisbon Municipal Police-CML (social sciences public officers with the mission to plan/follow up the community policing projects)
- Community (i.e. residents; social partners) in the community policing neighbourhoods.



7 What are the components/ elements that make up your toolkit?

7.1 Communication materials

Community policing communication materials and 'container' (i.e. presentation box or similar physical object). Key components of the 'container' being:

- Brochure (concept overview; methodology; current locations of community policing projects; community policing teams; contacts; etc.) QR code to link to video.
- Video (short and attractive video / animation / presentation / storytelling (What is Community Policy? Why is it useful? How is it implemented in Lisbon? By whom? Where?...)
- The focus of the Toolkit is on changing the mindset of senior officers, the container or box might be, for example, a slip case in the shape of something relevant (e.g. an image relating to a safe neighbourhood?)

7.2 Pen drive

A community policing pen drive (and / or website) containing key components:

- Digital version of the above materials, to be made available on a website
- Lisbon Community Policing updates

7.3 Launch event

Half day "Launch event" for engagement of senior officers in the Lisbon Community Policing strategy and planning



7.4 Engagement strategy

Community Policing Engagement Strategy

Process map of strategy for engaging Senior Police Officers and decision-makers in Community
Policing planning and delivery. E.g. include programme of collaborative planning sessions (twice
yearly)

7.5 Planning sessions

Twice yearly Collaborative Planning Sessions ("breakfast sessions") — working sessions to plan delivery of community policing strategy

- Targeting senior officers and senior decision-makers
- Discuss community policing strategy in Lisbon and the deployment of police officers in the neighbourhoods
- Support materials for these sessions:
 - Standardised agenda
 - Terms of reference for attendees / senior officers
 - Standard progress report template
 - Standard form for identifying "Priorities for roll-out of community policing"

7.6 Celebration event

Annual Community Policing 'celebration' event (name to fit with overall branding)

- Overview of what has been achieved
- Award scheme (i.e. Community Police Officer of the year)

7.7 Newsletter

Newsletter / update

• Monthly highlights / visual communication of Community Policing (i.e. short newsletter with the main information of community policing projects, activities, impact etc.)



7.8 Handbook (longer-term goal)

• Concept overview; methodology; current locations of community policing projects; community policing teams; contacts; etc.). Title: ("Manual do policiamento Comunitário em Lisboa"/Lisbon Community Policing Handbook)



8 How is the toolkit used?

The toolkit will have three 'touchpoints' (key moments of interaction with the toolkit), each with their own specially designed format:

Touchpoint 1 – Introducing community policing to senior officers

• Community policing communication materials 'container' with a pen drive provided to users.

Touchpoint 2 – Inducting Seniors officers into sustained engagement

• Launch event for engagement of senior officers in Community policing planning

Touchpoint 3 – Senior Officers ongoing engagement and co-working

- 2 annual Planning Labs (working sessions on the planning of the community policing strategy in Lisbon and the community police officer's deployment)
- Newsletter / update



9 What change will the toolkit create?

- Senior police officers will be better informed regarding community policy methodology and impact
- Engagement of senior police officers in community policing planning will be improved
- The number of times senior police officers divert community policing officers to other activities will be reduced
- Increased understanding, engagement and support of community policing by senior officers will improve morale of community policing officers
- Engagement of Senior officers will enable a more participative and inclusive methodology

Increased engagement of senior officers in co-production of community policing strategy will support development of new ideas for Community Policing implementation in the field.



10 What is needed to enable this concept to work?

Support required from key decision-makers

- Commanders' approval for the toolkit most important. To support this, the Lisbon Municipal Police-CML will develop a toolkit prototype to share with the commander early on in the design development process. (e.g. Second Commander and/or even the commander 2 or 3 people) This will be done in March and in April 2020.
- To support improved stakeholder buy-in and the brochure will include an introduction from the Commander (and Mayor/Deputy-Mayor) to give it weight. The Commander (and Mayor/Deputy-Mayor) could also introduce the video.

Resources required

- Time (e.g. senior police officers with time for presentations, meetings, etc.)
- Printing materials CML estimate requiring 20 presentation containers initially; and 30 for later on i.e. 50 in total.
- Video equipment
- Pen drive (x50)

Next steps...

- February 2020 Report for EU on CML Toolkit
- March 2020 Presentation to Lisbon Municipal Police-CML Commander/Deputy-Commander

Prototyping and demonstration: Demonstrate the CML toolkit (e.g. this might be the launch of the toolkit and one meeting with senior decision-makers).



11 Feedback from Advisory Board

- The primary focus of the toolkit should be the users.
- Senior officers / decision-makers might need to be further convinced of the benefits of community policing (e.g. social and economic benefits of community policing; presentation of qualitative and quantitative indicators). CML should consider developing focused and persuasive communication materials, as well as collecting testimonials from partners about the 'added value' of community policing. The value of 'story-telling' was highlighted.
- There is published evidence of the benefits of community policing and Jaap de Waard would be happy to recommend published articles on the impact of community policing on crime and feelings of security. This type of evidence would also be useful in a general introduction to the Toolkit on Community Policing: 'Context to community policing' and 'What Works'. Such evidence may also be presented to LEAs and security policymakers in a CCI policy briefing.
- CML must attempt to understand the actions of senior managers. Senior managers may utilize community police officers for other tasks because they are under pressure to respond to incidents and lack sufficient resources. Senior managers may require flexibility to respond to incidents / deal with major events at certain times of year (e.g. during the Christmas period).
 CML might have to find a compromise / different solution. Communicating the benefits of community policing may not bring about a change in behaviour amongst senior managers, who may simply be responding to pressure to deliver a service. Note that "Education is the weakest method of changing behaviour".
- Careful thought needs to be given to how to involve senior managers in community policing.

 The selection process of senior police officers to participate in the toolkit implementation must take into account their interest and motivation towards the community policing model.
- From an ethical perspective, it is important to understand and critically reflect on the role of police in society, as well as demonstrate that the approach is effective.



12 Next steps

March 2020

- Review requirements capture research in order to identify / better understand senior officer priorities, values and issues.
 - For example: What are their targets? What are current priorities / issues? What are the different resource issues at particular times of year, particular locations, etc.
 - OUTPUT: List of senior officer priorities (draft 1).
- If necessary, conduct further research to identify / better understand senior officer and senior decision-maker priorities, values and issues
 - For example, conduct additional interviews, attend senior manager briefings / events
 - OUTPUT: Revised list of senior officer priorities (draft 2)
- Organise meetings with the Commander and Second Commander to:
 - Present the toolkit Concept (as presented at Barcelona)
 - Discuss the issues the toolkit seeks to address
 - Explore how community policing might support / help them to meet their priorities.
 - OUTPUT: Revised list of senior officer priorities (draft 3)
- Skype meeting with USAL to discuss outputs and toolkit content development
 - Discuss involvement of other resource (e.g. LOBA)

April 2020

- Develop branding and visual identity for Toolkit
 - Develop concept prototype for toolkit container (2D visual mock-up)

May – June 2020

• Production of video (storyboard, interviews)




